

## Registration for ProWein 2014 Now Open

*Exhibitor registration documents for ProWein 2014 – in Düsseldorf from 23 to 25 March 2014 – are now available from [www.prowein.com](http://www.prowein.com) (in the “Exhibitor Service” section).*

Companies already taking part in the leading fair for the international wine and spirits sector this year will benefit from a simplified registration procedure: when you enter your access code (find this on your old admission documents) you call up an already filled out form that can be updated as required. Over three intense days of trade fair in Düsseldorf ProWein 2013 brought together 4,783 exhibitors from 48 countries and more than 45,000 trade visitors from throughout the world. Alongside a constantly good level of demand from Germany a further rise was particularly seen in the number of international visitors from all relevant wine import markets. This means the proportion of international visitors rose by 9 points to 43%.

Next year ProWein will be celebrating its 20<sup>th</sup> anniversary. The dates are 23 to 25 March 2014.
